TLS Tuition Assistance Information

Current families of Trinity Lutheran School who are members of Trinity Lutheran Church and are interested in applying for financial assistance for tuition can do so through the FACTS Management system either online at factsmgt.com/aid or by calling a FACTS Customer Care Representative at 866.441.4637. Be aware either application option requires you to upload or fax the required supporting documents. Your application is not complete without these documents. Incomplete applications will not be considered.

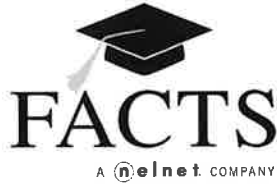
If you are a member of another congregation, please contact your congregation regarding tuition assistance. You will NOT be applying via FACTS.

Applications for Tuition Assistance for the 2018 – 19 school year will be accepted beginning Tuesday May 1, 2018. The application period will continue through Friday, July 20, 2018. Tuition Assistance awards will be announced the week of August 6, 2018.

Families enrolling in Trinity Lutheran School after the application deadline of July 20, 2018 will be considered case by case. Information on how to apply for assistance after the deadline can be received from the school office.

Tuition Assistance determinations are governed by the TLS Board of Education. The Chairman of the Board is Mr. Marc Montez.

Frequently Asked Questions

Q. Who sets the application deadlines?

A. Application deadlines are set by your institution. If you are applying after the deadline, please contact your school to make sure your application will be accepted.

Q. Is the application process secure?

A. Yes. All documentation received is imaged upon receipt and then destroyed. Then, the application data becomes property of the applicable institution.

Q. What happens after I apply?

A. You can log into online.factsmgt.com/aid to check the status of your application. Please allow two weeks for processing.

Q. Does the FACTS Grant & Aid Assessment process require a credit check?

A. No, FACTS does not require a credit check.
